About the scheme:

Musical instruments or equipment have been essential items for the students and artistes to carry out their learning or performance. The scheme is to support many talented students and budding artistes, who are economically weal but in need of instruments / equipment for their learning and performance purpose to help them groom towards professionalism.

Students (300 number) will be supported once in an academic year.

Procedure for submission of application:

Application format is made available on Department's website: **artnculturemanipur.gov.in** through notification in print & electronic media. Application Form may be downloaded from this website and the duly filled in application form should be submitted to the Directorate of Art & Culture, Government of Manipur office at Palace Compound, Imphal along with a covering letter addressed to the Director (Art & Culture). Last date of receipt of application is 20th August 2022 (5.00 pm.)

Eligibility:

- (i) Students of Government Dance College, Shree Shree Bal Mukunda Dev Music College, Imphal Art College, Manipur University of Culture, Jawaharlal Nehru Manipur Dance Academy and Manipur University (Dance, Music and Fine Art Department)
- (ii) Applicant should be pursuing a course in one of the art forms
- (iii) Applicant should be below 30 years of age (age to be reckoned on 1st April)
- (iv) A student may avail benefit of this scheme twice during his studentship with a gap of one year.
- (v) The extent of financial assistance will be decided by the Screening Committee

Documents to be enclosed:

- (i) Reading Certificate
- (ii) Age proof certificate
- (iii) Certificate from the teacher on requirement of instruments / equipment
- (iv) Income Certificate of the parents as well as applicant (annual family income of the parents should be less than Rs 1,00,000/- (Rupees one lakh) per annum
- (v) Income Certificate issued only by a Gazetted Officer will be accepted. However, income certificate issued by any officer / teacher belonging to the institution in which the applicant is studying will not be accepted.
- (vi) Bill / Voucher for purchasing the equipment / instrument
- (vii) Bank Account detail of the applicant

Method of Selection & Mode of Release of Fund:

Selection of students / artistes will be done by a Screening / Selection Committee constituted by the Government. Amount of assistance will be released to the personal account of the beneficiary through DBT.
